# **End User License Agreement**

Alfa Horizont, LLC (hereinafter - the Company) is engaged in the collection and processing of personal data on the website at www.alfahorizont.ru (hereinafter - the Site) and a Site User (hereinafter - the User) provides personal data on the conditions in accordance with the Agreement (hereinafter - the Agreement). If You do not accept the terms hereof, please do not use this Site.

#### 1. General Terms

1.1 This Site and all rights related to the Site belong to Alfa Horizon, LLC. 1.2 The materials of the Site are available for informational purposes. Should You use the materials of this Site (quote in full or partially), the You shall place a link to the Site or mention the Company name.

1.3 The terms of the Alfa Horizont, LLC used on the Site refer to Alfa Horizont, LLC, unless a special context specifies a different meaning. 1.4 Any information about the Company, its products and services, as well as any other information published on the Site, is provided based on the data available to the Company. 1.5 This Site and the software it uses are provided to Users "as is," without warranty of any kind, explicit or implied. The information contained on this Site is not exhaustive. Despite the best efforts of the Company, the information may be inaccurate, outdated, or not applicable in a particular situation. 1.6 The Company has the right to make changes to this Site any section without prior notice. It may also suspend certain sections of the Site or the entire Site at any time at sole discretion. The availability of a specific product type, the possibility of services providing or works performing, as well as their cost shall be agreed before starting cooperation.

## 2. Subject of the Agreement:

2.1. This Agreement regulates the procedure for collecting and processing personal data of Site Users when they register on the Site (filling the feedback forms, subscribing to news, etc.). 2.2. Personal data collection is done only after the User enters into this Agreement. The User provides personal data solely at his own will and in his own interests. 2.3. Confidentiality regarding personal data is ensured from the moment when this data was submitted by the person to whom this data relates. 2.4. The User's personal data is provided with appropriate security measures and is used only for processing User requests on the Company's Website. 2.5. The Company analyzes traffic on its Site to understand User requirements and improve the Site based on them. For statistical purposes, only anonymous, aggregated data is evaluated during web analysis.

### 3. Concept and Composition of Personal Data

3.1. The User's personal data means information on an individual or legal entity that is necessary for providing more detailed information on the Company's products and services, as well as for providing services by the Contractor. 3.2. Personal Data Composition: 1) for individuals: full name, corded (mobile) phone number, email address. 2) for legal entities: name of the organization, legal address, full name of the contact person, corded (mobile) phone number, email address.

# 4. Rights and Obligations of the Company

- 4.1. The Company shall:
- 1) collect personal data to the extent not exceeding the volume necessary to provide services and meet the User's requests on the Site;
- 2) not transfer personal data to third Parties without the User's consent, except in cases provided for by the legislation of the Russian Federation; 3) not publish the personal data received, except for the ones the User gave his explicitly consent to their publication;
- 4) ensure the protection of personal data from unlawful use or loss in accordance with the procedure established by the legislation of the Russian Federation.

#### 5. Rights and Obligations of the User

5.1. The User shall:

- 1) send only reliable personal data to the Company;
- 2) not use or send personal data of third Parties without their consent. When placing personal data of several Users by one User, it is assumed that the User has the necessary permissions;
- 3) notify about changes in personal data in cases where this may affect the Company's services performance;
- 5.2. the User has the right to:
- 1) request the deletion or correction of his personal data. Personal data of the Company's Website User is deleted upon the User's request to the email address <a href="mailto:info@alfahorizont.ru">info@alfahorizont.ru</a>
- 2) refuse to send personal data to the Company.
- 6. Protection of Personal Data.
- 6.1. To protect the User's personal data, the Company:
- 1) shall define specially authorized Employees and the procedure for accessing personal data;
- 2) shall not allow the personal data transfer to third Parties without the User's consent.

## 7. Responsibility

- 7.1. The Company is not responsible for unauthorized distribution of personal data, if the Company has taken all measures in its power to ensure the protection of personal data, but unauthorized access to personal data occurred as a result of illegal actions of third Parties (hacking, attack) or vulnerabilities in the software.
- 7.2. In all other cases the liability of the Parties shall be determined in accordance with the current legislation of the Russian Federation.
